## LEGAL DESCRIPTION

All the following real estate being more particularly described as follows:

thence South 00°29'36" West 70.77 feet along the west line of said tract to a point, witness a wood post found West 0.6 feet and South 0.6 feet;

thence South 89°50'32" West 271.07 feet along the south line of Tract 3 to the southwest corner of Tract 3;

thence North 00°07'54" East 197.79 feel to a 1 inch iron pipe found at the northwest corner of Tract 3 and on the north line of Out Lot 47;

thence North 89°47'52" East 169.67 feet along the north line of Out Lot 47 to a 1 inch iron pipe found;

thence South 89°35'39" East 71.36 feet along Out Lot 47 to a wood corner post found;

thence North 00°53'53" East 68.14 feet along the west line of a 5.61 foot strip described in Tract and the west line of Lot 214 to a 1 inch iron pipe found at the southwest corner of a 4.305 foot strip described in Tract 1;
